Time line for DMC Plan including comprehensive statewide juvenile justice data collection plan

May

- 1st draft of Joint Judiciary Interim Committee report prepared.
- Requested to be on Joint Judiciary Interim Committee agenda at May 28 meeting.

June

- 2nd draft of Joint Judiciary Interim Committee report prepared
Complete data entry for arrest and detention into web based DMC site.

July

- Send out draft of Joint Judiciary Interim Committee report for SACJJ data committee and DMC committee comments and critique – by July 14.

August

- Present final draft to the SACJJ at August 6th meeting in Worland.
- Present DMC web based data for discussion and review of Relative Rate Index.
- Present the Wyoming DMC three year plan to the SACJJ.
- Testify before the Joint Judiciary Interim Committee August 17 or 18.

September

- Have Mr. Bob Peake, Youth and District Court Services Bureau Chief, Montana Supreme Court, give presentation on data collection and uses for data as utilized by the State of Montana.

October/November

- Begin DMC Assessment/Diagnosis and Intervention phases in selected communities. This will reinforce the necessity in collection of reliable juvenile justice contact points data at the community level.
